1. Summary

This report provides a statistical analysis of the Kent State University 8-Campus-System enrollment for the Summer I&II 11 Term. The Kent State University 8-Campus-System experienced a 3.73% increase in unduplicated student headcount; 12,745 students in Summer I&II 11 compared to 12,287 students in Summer I&II 10 for a net increase of 458 students. Undergraduate enrollment increased by 5.44% (500 students) and graduate enrollment decreased by 1.36% (-42 students).

Student FTE increase by 5.01%; the Kent State University 8-Campus-System generated 103.70 more FTE compared to Summer I&II 10. Undergraduate FTE increased by 6.81% (101.53 FTE) and graduate FTE increased by 0.38% (2.17 FTE).

The undergraduate mean unit load (MUL) is 2.46 compared to 2.43 in Summer I&II 10. Graduate MUL is 2.86 compared to last year's 2.81 and the campus MUL is 2.56 compared to 2.53 last year.

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15; during Summer terms, FTE is the students' total credit hours divided by 30.
