### FIFTEENTH DAY ENROLLMENT STATISTICS

#### 1. Summary

This report provides a statistical analysis of the Salem Campus enrollment for the Fall 09 Term. The Salem Campus experienced a 20.32% increase in student headcount; 1587 students in Fall 09 compared to 1319 students in Fall 08 for a net increase of 268 students. Undergraduate enrollment increased by 20.64% (271 students) and graduate enrollment decreased by 50% (-3 students).

Student FTE increase by 23.75%; the Salem Campus generated 199.53 more FTE compared to Fall 08. Undergraduate FTE increased by 23.86% (200.20 FTE) and graduate FTE decreased by 52.76% (-0.67 FTE).

The undergraduate mean unit load (MUL) is 9.84 compared to 9.58 in Fall 08. Graduate MUL is 3.0 compared to last year's 3.17 and the campus MUL is 9.83 compared to 9.55 last year.
