# FIFTEENTH DAY ENROLLMENT STATISTICS

## 1. Summary

This report provides a statistical analysis of the Stark Campus enrollment for the Fall 13 Term. The Stark Campus experienced a $0.45 \%$ increase in student headcount; 4,886 students in Fall 13 compared to 4,864 students in Fall 12 for a net increase of 22 students. Undergraduate enrollment increased by $0.42 \%$ ( 20 students) and graduate enrollment increased by $4.17 \%$ ( 2 students).

Student FTE decrease by $3.46 \%$; the Stark Campus generated 109.06 less FTE compared to Fall 12. Undergraduate FTE decreased by $3.46 \%$ ( -108.60 FTE) and graduate FTE decreased by 3.62\% (-0.47 FTE).

The undergraduate mean unit load (MUL) is 9.40 compared to 9.78 in Fall 12. Graduate MUL is 3.76 compared to last year's 4.06 and the campus MUL is 9.34 compared to 9.72 last year.
