# FIFTEENTH DAY ENROLLMENT STATISTICS

**Tuscarawas Campus** 

Summer I&II 12

### 1. Summary

This report provides a statistical analysis of the Tuscarawas Campus enrollment for the Summer I&II 12 Term. The Tuscarawas Campus experienced a 15.43% decrease in student headcount; 433 students in Summer I&II 12 compared to 512 students in Summer I&II 11 for a net decrease of 79 students. Undergraduate enrollment decreased by 15.43% (-79 students) and graduate enrollment increased by 0% (0 students).

Student FTE decrease by 12.44%; the Tuscarawas Campus generated 7.23 less FTE compared to Summer I&II 11. Undergraduate FTE decreased by 12.44% (-7.23 FTE) and graduate FTE increased by 0% (0.00 FTE).

The undergraduate mean unit load (MUL) is 1.76 compared to 1.70 in Summer I&II 11. Graduate MUL is 0.00 compared to last year's 0.00 and the campus MUL is 1.76 compared to 1.70 last year.

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15; during Summer terms, FTE is the students' total credit hours divided by 30.
